

#### **ACCREDITATION**

Accreditation is a comprehensive quality review of a program and its service delivery and related business practices.



#### CERTIFICATION

Certification demonstrates a program's capacity to deliver a specific level of care, thereby differentiating between the many levels of care

# WHY CERTIFICATION?

- Verify implementation of The ASAM Criteria
- Support adoption of standards of care to improve the quality of addiction treatment
- Accurately differentiate between levels of care
- Highlight treatment programs that have evidence-based policies and procedures

### What Does Certification Address?

The ASAM Criteria includes standards for multiple components of care, including:

- 1. Six Dimensions of Multidimensional Assessment
  - Withdrawal potential
  - Medical needs
  - Emotional and behavioral conditions
  - Readiness to Change
  - Potential for relapse
  - Individual's recovery environment
- 2. Decision rules for interpreting the multidimensional assessment to match patients to the right level of care to meet their treatment needs
- 3. A framework for the continuum of addiction treatment services




### What Does Certification Address?

The ASAM Criteria includes standards for multiple components of care, including:

- 4. Six Characteristic Service Standards
  - Setting
  - Staff
  - Support systems
  - Assessment and Treatment Planning
  - Therapeutic Services (therapies)
  - Documentation



### The Path to Certification



Decide to seek certification Conduct assessment of policies & procedures

Update policies & procedures, prepare for survey

Apply for certification

Undergo survey

Receive certification decision

# How long should preparation take?

- 2 months or more
  - Based on CARF's experience
- It can take significantly longer
  - State of ASAM Criteria Implementation
  - Size of facility
  - Seeking multiple certifications
- Think critically about your preparation
  - Program bandwidth to have certification committee
  - Use the ASAM Level of Care Certification
     Standards Manual and Survey Preparation
     Workbook to identify possible gaps between
     required elements and current program status
