Eligibility Requirements & Pathways to Certification

Key Eligibility Requirements for Addiction Medicine Exam

- Current certification by any of the ABMS Member Boards.
- ABPM will accept current certification by the AOA for the Fellowship pathway only.
- Medical degree or equivalent
- Medical licensure: current, unrestricted and valid in US or Canada in all jurisdictions where the physician is licensed
- Training or experience in Addiction Medicine
 - Practice Pathway
 - ACGME-Accredited Fellowship in Addiction Medicine

Practice Pathway

- Provides opportunity for physicians who have significant Addiction Medicine practice experience or training but who have not completed an ACGME-accredited Addiction Medicine fellowship to qualify for the certification exam
- Practice Pathway will be open through 2025 Exam Cycle
 - Original Expiration Date was at the conclusion of the 2021 Exam Cycle
 - ABPM sought and received a 4-year extension of the Practice Pathway
- Two pathway tracks:
 - Time in practice
 - Non-ACGME-Accredited Fellowship training

Practice Pathway: Time in Practice

- 1,920 hours of relevant practice in ADM at the subspecialty level
 - Completed over at least 24 months
 - Need not be continuous, but must be within 60 months immediately preceding June 30 of the application year
- Broad-based, professional activity with significant addiction medicine responsibility
 - Clinical care including prevention and treatment of individuals at risk for substance use disorders (minimum 480 hours)
 - Teaching, research and/or administration activities (maximum 1,440 hours)

Practice Pathway: Non-ACGME-Accredited Fellowship

- Successful completion of at least 12 months of fellowship training accredited by the American Board of Addiction Medicine (ABAM)
 - Documentation of the training curriculum
 - Description of applicant training experience
 - Verification by Program Director
- If fellowship training is less than 12 months, training time may be applied to the "Time in Practice" track

ACGME-Accredited Fellowship Pathway

- Successful completion of a minimum of 12 months of ACGMEaccredited fellowship training
 - If fellowship program is approved for more than 12 months of training, successful completion of all years of training for which the fellowship program is accredited
- Addiction Medicine fellowship programs began accreditation process through ACGME in February 2018

Examination Content, Questions & Timeline

Exam Content

- Assesses ability to apply knowledge rather than recall of isolated facts
- Focuses on high-frequency and/or high-impact patient problems
- Emphasizes clinical situations and decisions arising in the experienced addiction medicine specialist's practice

Exam Questions

- Multiple choice questions; single-best answer
- Types of Multiple-Choice Questions
 - **Recall**: specific important facts
 - Interpretation: e.g., identify a fatal study flaw, diagnose a patient
 - **Problem Solving**: e.g., judgment about clinical treatment, healthcare administration, study design, 2x2 tables, etc.
- Calculator, drug name list, and normal range values provided

What is NOT on the Exam?

- True/False items
- K-type questions: choose appropriate set of correct answers
- Trick questions
- "Experimental" questions

Exam Timeline

- Late October early November: all exams administered
- November/December: all exams scored
- December/January: Key validation process
 - Each question's performance reviewed
 - Focus on low-performing question
 - Questions may be retained, re-keyed, or dropped based on performance
 - Each candidate's exam is then rescored
- January: Board reviews exam results and characteristics
 - Scores equated to a standardized score so passing standard represents the same level of proficiency year after year
 - Eliminates effects of variance in exam difficulty from year to year

Certificate

- Attests that all requirements of Certification in the Specialty/Subspecialty have been met.
- Dated January 1 of the year after the exam.
 - Subject to continuing compliance with Continuing Certification Program (CCP) requirements, Certificate will expire December 31, ten years after issuance
 - E.g., for those passing the 2022 examination, the effective date of the Certification will be January 1, 2023 through December 31, 2032.
- All Addiction Medicine Diplomates Certified by the ABPM are subject to the Annual Fee




Exam Registration & Pass Rate Data

Continuing Certification Program Update

Updated ABMS Standards for Continuing Certification

- ABMS approved updated Standards for Continuing Certification
 in October 2021
 - Provides framework for a meaningful process of ongoing professional development and assessment
 - All ABMS Member Boards, including ABPM, are obligated to implement the updated standards in their continuing certification programs, using a phased approach

Transitioning to Continuing Certification


- <u>Phase 1</u> of the ABPM's CCP launches <u>January 1, 2023</u>, when all Time-Limited Diplomates will be required to:
 - Attest online to earning 20 CME credits per year
 - 6 CME Credits MUST BE Certificate Specific
 - Pay the annual fee of \$175
- <u>Phase 2</u> of the ABPM's CCP, including a Longitudinal Assessment Program (LAP) is expected to launch for all Specialties & Subspecialties on <u>January 1, 2025</u>

LAP Pilot in Clinical Informatics

- ABPM's LAP Pilot includes all Diplomates Certified by the ABPM in Clinical Informatics
- Cohorts broken down into separate groups having 3, 5, or 10 minutes to answer each MCQ
- Every six-months required to answer 12 MCQs using the ABPM's on-line assessment tool
- Open-book Exam
- Pilot launched April 1, 2021 and will conclude March 31, 2023
- Segment 1 Results very promising

AOA Certification in Addiction Medicine

- There are 260 diplomates who hold the certification in addiction medicine
- 97% pass rate for initial exam
- Exam is offered every year in November
 - Registration for the Nov. 7-9, 2022 exams is now open.
- Remotely, proctored delivery platform
 - ~90% examinee satisfaction with the platform
- Fees:
 - Initial: \$2000
 - OCC: \$1500





Achieving Certification





Take the Addiction Medicine written certification exam administered annually

- 200 items
- 4-hour exam, 15-minute break



Pathway 1: Complete an AOA or ACGME Fellowship in Addiction Medicine.

Pathway 2: Clinical Pathway

- Complete 1000 hours of practice time within a 2-year period
 - May be a combination of direct patient care and published research, teaching activities within an accredited medical school or ACGME residency, and/or live or recorded live ACCME and/or AOA CME activities.
 - No more than 500 hours may come from CME activities.
- An active ABAM certificate will waive the need for the 1000-hour attestation.
- Certificate of completion of an ACAAM (formerly TAMF and ABAM) fellowship within the five years prior to the application start date for that year will waive the need for the 1000-hour attestation.

COMPONENT 1: LICENSURE	AOA board-certified physicians must hold a valid, active license to practice medicine in a U.S. state, commonwealth, District of Columbia, or U.S. territory.	
COMPONENT 2: LIFE-LONG LEARNING	A diplomate must complete the CME requirements in their primary specialty/subspecialty. No additional CME is required to maintain the Addiction Medicine certification at this time.	
COMPONENT 3: COGNITIVE ASSESSMENT	To complete Component 3 requirements OCC in the subspecialty of Addiction Medicine, a physician must pass a written examination once per 10-year OCC cycle.	
COMPONENT 4: PRACTICE PERFORMANCE ASSESSMENT AND IMPROVEMENT	Engage in continuous quality improvement activities (requirements vary by specialty).

WHEN YOU DON'T UNDERSTAND THE QUESTION IN AN EXAM

Some quick suggestions

- Focus studying on topics and material you don't see regularly in your clinical work
 - e.g., the Hallucinogens and Dissociatives—in each applicable section, i.e, pharmacology, intoxication, withdrawal, treatment.
- Review/skim the topics you know well
- Do Not Neglect "Soft Topics,"
 - Ethical, Legal, Liability ;Harm Reduction; Non-Pharmacologic Treatments (MI, CBT, DBT)
- May be expected to know "classic" articles, e.g. MOTHER study



Additional Tips


- High yield topics include neurotransmitters, receptors, neurobiology
- Read questions carefully before answering
- Work with a study partner to keep oneself accountable to a study plan – especially helpful for those in the Practice Pathway



- Results do not arrive until February.
